

The vacation rental market is booming!

Key Attractions that Promote Growth on Navarre Beach:

- Proximity to the Beach and Water Activities
- Longest Fishing Pier in the Gulf of America (approx. 300,000 visitors, annually)
- Artificial Reefs in the Santa Rosa Sound & Gulf of America
- Turtle Conservation Center (approx. 63,000 visitors, annually)
- National Champion Beach Safety Program



Reasons for Increase in TPLE's:



- Increased rental market prices hotels/motels
- Tourist Development Office
- Chamber of Commerce
- Multiple Families Vacationing Together

Fire District's Role:



- Fire Chief - primary advocate for public and first responders' safety
- All things being equal = flourish
- Mutual exclusivity = safety/profitability

Define Transient Public Lodging Establishment (TPLE)

What is TPLE?

- Part 1 of Florida State Statute 509, Public Lodging and Public Food Service Establishments.
- 509.013(4)(a)(1) “Transient public lodging establishment” means any unit, group of units, dwelling, building, or group of buildings within a single complex of buildings that is rented to guests more than three times in a calendar year for periods of less than 30 days or 1 calendar month, whichever is less, or which is advertised or held out to the public as a place regularly rented to guests.

What is a “Vacation Rental”?

- Florida Statute 509.242(1)


- **1) A public lodging establishment shall be classified as a hotel, motel, bed and breakfast inn, or *vacation rental* if the establishment satisfies the following criteria:**

- (c) Any unit or group of units in a condominium or cooperative or any **individually** or collectively **owned single family**, two family, three family, or four family house or dwelling unit that is also a **transient public lodging establishment...**



Using the correct language

- Not all vacation rentals are transient public lodging establishments.



Who Licenses TPLE's?

- Department of Business and Professional Regulations (DBPR)
 - Division of Hotels and Restaurants.

633.206 Uniform firesafety standards.—The Legislature hereby determines that to protect the public health, safety, and welfare it is necessary to provide for firesafety standards governing the construction and utilization of certain buildings and structures. The Legislature further determines that certain buildings or structures, due to their specialized use or to the special characteristics of the person utilizing or occupying these buildings or structures, should be subject to firesafety standards reflecting these special needs as may be appropriate.



2023 Florida Statutes
Chapter 633
Fire Prevention & Control

633.208 Minimum firesafety standards.—

(1) The Florida Fire Prevention Code adopted by the State Fire Marshal, which shall operate in conjunction with the Florida Building Code, shall be deemed adopted by each municipality, county, and special district with firesafety responsibilities. The minimum firesafety codes do not apply to buildings and structures subject to the uniform firesafety standards under s. 633.206 and buildings and structures subject to the minimum firesafety standards adopted pursuant to s. 394.879.

Florida Statute 633.208 Minimum Fire Safety Standards

FFPC adopted by the State Fire Marshal...shall be deemed adopted by each municipality, county, and special district with fire safety responsibilities.

Each municipality, county, and special district with fire safety responsibilities **shall** enforce the FFPC.

Florida Statute 633.208 Minimum Fire Safety Standards

- What if I said, “I’ll enforce Chapter 16, New Day-Care Occupancies, but not Chapter 31, Existing Apartment Buildings.” What would your response be?
- How about, “I’ll enforce Chapter 12, New Assembly, but not Chapter 37, Existing Mercantile Occupancies.” Your response to that?
- Indiscriminate? Arbitrary?
- Would my decision/s be inconsequential?

Florida Statute 633.206 Uniform Fire Safety Standards

The Legislature hereby determines that to protect the public health, safety, and welfare it is necessary to provide for life safety standards...

The legislature further determines that certain buildings or structures, due to their **specialized** use or **special** characteristics...should be subject to fire safety standards reflecting these **special** needs.

(1)The Department of Financial Services shall establish uniform fire safety standards that apply to:

(b)All new, existing, and proposed hospitals, nursing homes, assisted living facilities ...**transient public lodging establishments**.

Fire Risks and Hazards Special to TPLEs

Transient Population (new guests unfamiliar with property)

Often not built or modified to commercial standards

Potential for overcrowding or use beyond intended purpose

Inconsistent application of safety features (smoke detectors, fire extinguishers, etc.)

Florida Statute 633.206 Uniform Fire Safety Standards

(1)(b) State Legislature mandates Local Fire Jurisdictions protect the health, safety, and welfare of “all new, existing, and proposed... nursing homes, assisted living facilities, adult family-care homes... transient public lodging establishments...”

(2)(b) All such local authorities shall enforce, within their fire safety jurisdiction, the uniform fire safety standards for those buildings specified in paragraph (1)(b)

What codes do we use to enforce?

- Florida Administrative Code Chapter 69A-43-Uniform Fire Safety Standards for Transient Public Lodging Establishments, Timeshare Plans, And Timeshare Unit Facilities’.
- 69A-43.018 One- and Two-Family Dwellings, ...Licensed as transient public lodging establishments, use Chapter 24 of Florida Fire Prevention Code is prescribed, except as modified by 69A-43.
- For Three-family and four-family dwellings licensed as transient public lodging establishments shall comply with Chapter 28, New Hotels and Dormitories or Chapter 29, Existing Hotels and Dormitories, of FFPC.

Inconsequential?

- (5) The State Fire Marshal may deny, refuse to renew, suspend, or **revoke the certificate of a fire safety inspector** if the State Fire Marshal finds that any of the following grounds exist:
- (f) **Failing to properly enforce** applicable fire codes...

Florida Statute 633.216(5)(f)






- Residential: \$537.40




Navarre Beach Fire Rescue District has approximately 1,200 Vacation Rentals

enforcement?



FS 633.202(6)

- “The Florida Fire Prevention Code does not apply to, and no code enforcement action shall be brought with respect to, zoning requirements or land use requirements.”

NBFR TPLE Inspections:

- . The focus will be on renter's safety.
- . Scheduled at the convenience of the owner or rental agent.
- . Minimal interruption to your rental business.
- . No charge for the inspection.

NBFR Inspection Checklist:

STREET NUMBERS:

- A street number shall be visible from the street (with contrasting colors) [NFPA 101 Ch 4.6.1.2]

FIRE EXTINGUISHER(S):

- Minimum – size 2A-10BC or as required by code [69A-43.018(7)]
- Shall have current inspection certification [69A-43-018(7)]
- Must be mounted no higher than 5 ft high and no lower than 4 ft above floor [NFPA 10 Ch 6.1.3.8.1, 6.1.3.8.3]
- Shall be in a conspicuous location and unobstructed [NFPA 10 Ch 6.1.3.1]
- Fire extinguishers shall be located so that the maximum travel distances shall not exceed 75 ft [NFPA 10 Ch 6.2.1.2.2]

ELECTRICAL:

- All circuits shall be identified, blanks in all unused circuits [NFPA 101 Ch 4.6.1.2]
- Extension cords shall not be used as permanent wiring [NFPA 101 Ch 4.6.1.2]

EGRESS:

- Keep primary and secondary exits clear and unobstructed [69A-43-018(4)(b), 69A-43.018(4)(c)1]

NBFR Inspection Checklist Cont.:

OTHER ITEMS:

- Transient Public Lodging Establishment License [69A-43.001, 69A-43.003]
- Contact numbers and procedures for reporting an emergency [69A-43.018(9)]
- Floor diagram: floor arrangement, primary and secondary exit locations, room identification and posted in a conspicuous location [69A-43.018(8)]

EMERGENCY LIGHTS:

- Battery powered emergency lighting shall be provided for a period of no less than one (1) hour to illuminate the primary exit [69A-43.018(6)]

SMOKE ALARMS:

- Working alarms shall be in each bedroom, one in common area of house, and one in hallways outside of bedrooms [NFPA 101 Ch 24.3.4.1]
- CO alarms in dwellings with gas appliances and/or attached garages (on every level) [Ch 24.3.4.2.1(1)(2)]
- **(Note: Additional items may be required per Florida Administration Code 69-A-43)**
